Participant Agreement & Parental Release

I, _____, am a participant in the **Weekend Academy for Sport & Society Training Camp** from **November 2007 to June 2008**.

As a condition of my participation in this program I agree to the following:

1. I will abide by the rules and regulations of the program as explained to me by the program coordinators.
2. I that it is MY RESPONSIBILITY to **always come dressed in sports (sneakers, shorts, sweat-suit, and camp shirt) and be prompt (“on-time”)** for all required program meetings and activities such as: classes, workshops, basketball instruction, and field trips. **I understand that chronic lateness, absence, and lack of participation in all activities will result in dismissal from the camp.**
3. I will respect camp property and act responsibly on camp grounds. I understand that I am responsible for any damage I may cause to any property at the camp location.
4. I will treat each person in the program with respect and courtesy. I understand that abusive language, bullying, hazing, threatening behavior, harassment, and fighting is strictly forbidden and any such conduct will result in immediate expulsion from the camp.
5. I understand that possession, use, consumption, or sale of any drug, (including cigarettes and alcohol, but not including prescribed medication if used as prescribed) is strictly prohibited. I understand that possession, use, handling, or sale of any type of weapon is strictly prohibited.
6. **I understand that photos, video, and other such recording devices will be used during the camp at the behest of the camp organizers and my signature along with that of my parent/guardian below demonstrate consent for such recorded statements, film, or photography to be used by the School District of Philadelphia, Pro Sports Community Consultants (PSCC), its affiliates, or the news media in its marketing effort or any other medium of communication (including newspapers, magazines, television, radio, pamphlets, brochures, reports, etc.) without any liability on the part of those aforementioned parties, its departments and/or employees. I therefore assume full responsibility for the release of information about myself and/or the person for whom I am granting permission, which will result.**

I have carefully read and understand this agreement. I (along with my parent/guardian) have had the opportunity to ask any questions I may have about the program and the rules I am hereby agreeing to follow. I understand that if I fail to abide by any of the conditions of this agreement, I may be dismissed from the program immediately or that I may be subject to other appropriate disciplinary action.
